2013 Youth World Archery Championships, Wuxi China

1. INTRODUCTION

1.1 This document details the requirements and processes that will be followed to determine the athletes to be selected by Archery Australia to compete in the 2013 World Youth Archery Championships, Wuxi China 1 September 2013 to 8th September 2013. The process is detailed to ensure the best athletes are selected while at the same time maintaining a fair and transparent process.

1.2 Definitions.

In this Selection Criteria the words and phrases below have the following meanings

| Athlete | means a person registered with Archery Australia who is trying for selection |

| MQS | means the minimum qualification score as detail in Schedule 4 |
| Nomination Committee | means the Archery Australia Selection Committee as appointed from time to time |
| WA | means World Archery |
| WYAC | means World Youth Archery Championships |
| QUALIFICATION PERIOD | 1 May 2012 to the 31st May 2013 |

2. ELIGBILITY

- 2.1 Only those athletes who have met the conditions detailed below will be recognised in the World Youth Championships Shadow Team and will be eligible for final team selection.
- a. Be an Australian citizen at the time of Team Selection.
- b. Be a current registered affiliate of AA.
- c. Complete and submit the appropriate forms detailed below by 5pm 13th May 2013 to the Archery Australia at;

- d. Application for Consideration for Selection form (Schedule 1)
- e. Parent/Guardian Acknowledgement (Schedule 2)
- f. Contact Details (Schedule 3)
- g. Event Details (Schedule 4)
- h. Colour copy of front page of Passport
- i. Have read and understood the Archery Australia Athlete Agreement and Code of Conduct, sign and submit. These documents can be found on the Archery Australia website www.archery.org.au under 2013 World Youth Championships page. Upon receipt of the documents detailed in this section a copy of the Archery Australia Athlete Agreement and Code of Conduct will be distributed, final team selection is contingent on signing and returning this form.
- j. Shoot MQS set out in Schedule 5 during the period 1 May 2012 12th May 2013.

To achieve the Minimum Qualifying standard, athletes are required to shoot either;

- An A Qualifier on at least one (1) occasion, or
- A **B Qualifier** on at least two (2) occasions.
- k. Submit MQS record form by 13th May 2013 (Schedule 6).
- I. Submit the Uniform Order Form (Schedule 7).
- m. Remain in "good standing" with AA and at all times by comply with the AA Athlete Agreement and Code of Conduct and otherwise conduct themselves in a way that does not bring their sport or the National Team into disrepute.

3. SELECTION PROCESS

3.1 At the conclusion of the qualification period AA will publish a list of athletes who have met the eligibility requirements. This list of athletes will form the 2013 Youth World Championships Shadow Team.

- 3.2 The 2013 Youth World Championships Team will be selected on the results of the 2013 Youth National Championships, target event.
- 3.3 The final team will be the first three (3) athletes in each division using the total score shot at the 2013 Australian Youth Championships (Target Evens), who are members of the 2013 Youth World Championships Shadow Team and have met the edibility requirements detailed in Clause 2.

Note - If there is a tie for a place the tie will be broken by using standard tie breaking procedures, if still a tie there will be a single arrow shoot off at the last distance shot.

- 3.4 If an athlete chooses not to accept their place on the team, the next eligible athlete in that division who is a member of the 2013 Youth World Championships Shadow Team will be appointed.
- 3.5 Upon completion of this selection process nominations will be sent to the Board for their approval.
- 3.6 No application will be recognised if received after 5pm 13th May 2013 or if the MQS scores have not been shot.

4. FUNDING

4.1 Funding will be provided in line with the Archery Australia Funding Policy No 1005 which can be found on the Archery Australia website <u>www.archery.org.au</u> under About Us/Policy and Procedures.

5. APPEALS

5.1 Any appeals or dispute will be dealt with as per the AA Appeals Process. The AA Appeals Process Policy No 1006 which can be found on the Archery Australia website www.archery.org.au under About Us/Policy and Procedures.

The FITA 50/720 round must be shot to comply with QRE Guidelines or in WA Registered events must be shot using multiple faces, 6 arrow ends in 240 seconds using 80cm 6 ring faces.
